

How Do I File for Unemployment Insurance?

- To file for unemployment insurance (UI) with the State of Hawaii, go online to https://huiclaims.hawaii.gov/#/login
 - a. If you've filed a claim before, click "Sign In".
 - b. If this is your first claim you've filed online, you will need to establish an online account with the State of Hawaii, click "Create Account". Follow the on-screen instructions to process a claim.
 - c. Once you create your account, you will be asked a series of questions regarding your employment for the past 18 months, such as, employer's name, address, dates of employment and reason for separation.
 - d. Be prepared to also provide your social security number and your bank information if you wish to elect direct deposit (routing and account numbers).



HELPFUL TIPS:

- If you have any trouble creating an account while trying to file a new claim, the
 alternative method of submitting your request is to go to https://huiclaims2020.

 hawaii.gov/initial-claim. This will bring you to the new webform that you can
 submit electronically. Once submitted you will see a "congratulations" screen but
 it may take days for you to receive a confirmation email.
- If you do not have access to a computer, please contact the State of Hawaii at (808) 762-5752 for a phone appointment.
- When filing for UI benefits, please list **your current company** (or the company you most currently worked for) as your employer.
 - a. If you are still employed, but experiencing a reduction in hours: Please select the reason "Still Employed, Reduction of Hours." Do not select "Temporary Lack of Work" or "Lack of work" as the UI Claims Office will consider you to be separated.
- After completing your initial claim, you'll also need to file a weekly claim certification (or weekly report of low earnings). This will also be done online for each week your either have 0 hours, or your hours are reduced. The State of Hawaii UI Claims Office will determine if you are eligible for benefits. Please be aware it is not up to your employer to grant you UI benefits. The State of Hawaii UI Claims Office will review the details of your case and render a decision based on applicable laws.

After you file for UI benefits, the State of Hawaii will determine the amount you qualify for in UI benefits aka your maximum weekly benefit amount (WBA). Gross wages from the past 18 months from all of your employers are used to calculate your WBA. If you are interested in estimating your WBA, please visit huiclaims2.hawaii.gov/UI_ClaimWEB/pages/calculator.jsf.

Recent Updates

The Governor announced on Monday, 03/16/20 that the one week waiting period will be waived; this means that you may qualify for UI benefits from the week you first file.

The Department of Labor and Industrial Relations (DLIR) announced on Monday 3/23/20 the availability of two phone numbers to help process unemployment claims while working on fixing the current online claims filing process. The phone numbers will be available during normal business hours of 7:45 a.m. to 4:30 p.m.
