It is recommended that performers be outdoors if possible and that performers who can do so wear masks. (Reopened June 1st) 	<ul style="list-style-type: none"> Indoor gatherings have expanded to a total of 50 persons. Outdoor gatherings have expanded to a total of 100 persons. Groups within gatherings are still limited to 10 people maximum, with exceptions for sports practices; - Canoe Paddling - 6-person and 12-person paddling Organized Team Sports - includes outdoor team sports such as baseball, softball, soccer, outdoor volleyball, outdoor basketball and other similar outdoor team sports. (Reopened June 15th) Competitive Team Play (Will reopen July 1st)

(Reopened June 1st) 	<ul style="list-style-type: none"> Limited to no more than 50% occupancy Maintain 6 feet physical distancing water fountains closed except for contact-free stations for refilling of water bottles Child care areas, self-service food and drink stations remain closed.
